A meeting of the Senate Committee on Economic and Small Business Development was scheduled for Thursday, April 25, 2019, at 1:00 p.m., in the 1200 Room of the Binsfeld Building.

The agenda summary is as follows:

1. Reported HB 4101 (Rep. Frederick) with recommendation and immediate effect.
2. Reported HB 4077 (Rep. Neeley) with recommendation and immediate effect.
3. Presentation by Brian Calley, President for the Small Business Association of Michigan.
