COMMITTEE MEETING MINUTES
June 18, 2019

A meeting of the Senate Committee on Regulatory Reform was scheduled for Tuesday, June 18, 2019, at 3:00 p.m., in the 1200 Room of the Binsfeld Building.

1. Reported SB 320 (Sen. MacGregor) with recommendation and immediate effect.
2. Testimony regarding SB 349 (Sen. VanderWall)
3. Reported HB 4510 (Rep. Farrington) with recommendation and immediate effect.
